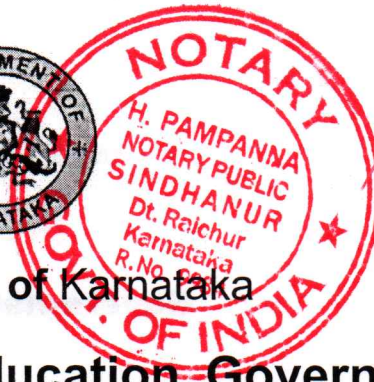

By the government to register reserved seats under the RTE. The government has enacted rules to facilitate enrollment in neighborhood schools where parents of children live in government and government – funded educational institutions. Regulatory Government will release the child fees recorded under RTE rule as described in clause.

4. As described in clause 3. Children bailed out any fees from these children. Govt bares the fees of children enrolled under RTE from time to time. Hence no kind of fees should be charged to these children.
5. The school and the school board are forbidden to make any capitation fees and voluntary donations from parents at any time during or after enrollment under RTE.
6. As per State Government notification Number : ED: 31: PGC: 2019, Date: 27.07.2019 school should publish the information of the departmental website and the school instruction board that No additional fees shall be charged beyond the prescribed fee.
7. Enrolment of students by the school / governing body should be done within the stipulated time.
8. The school / governing body cannot refuse enrolment against the following factors.
 - i) Due to lack of proof of age,
 - ii) based on caste, creed, place of birth and language,
 - iii) seeking admission after extended period of admission.
9. Fire safety and building safety certification from relevant authorities and child learning safety in accordance with K.S.C.P.C.R and N.C.P.C.R. and RTE rule should be ensured.
10. The school / governing body may as follows:

- i) Enrol any child in any class until he completes his primary education and higher primary education at the school and should Not to be held or expelled from school.
- ii) No child shall be physically or mentally abused.
- iii) No child will need to pass any board exam until they have completed the education.
- iv) Every child who completes primary education shall be certified under the RTE Rule-21 and Karnataka Education Act and Rules.
- v) The school shall also include special needs children with special needs as per the provisions of RTE Act and Rules and Karnataka Education Act and Rules.
- vi) Appointed Teachers shall have the minimum qualifications as prescribed by the Primary and Middle School Teachers in the RTE Act and Rules and the Karnataka Education Act and Rules and Govt. Directives.

vii) Teachers are paid and notified by the Employee State (ESI) through Notification (Provident Fund (PF) and Payable Bank and Other Salaries.



viii) Teachers should Perform the duties specified under Rule-17 of the Rules and do not engage in private tuition for supervisory considerations.

11. School should follow the syllabus and text books of the educational authority in which the school is affiliated.
12. The school shall admit the students in accordance with the facilities available in the school as specified in the Karnataka Education Act and Rules
13. maintaining school rules and standards as stipulated in Section 19. Appointment of departmental staff as prescribed in the Karnataka Education Act and Rules.
14. Do not open classrooms (branches) unauthorizedly in or outside the school premises.
15. School buildings and other infrastructure for the school shall not be provided for any commercial activity or political or educational activities in the day or night.
16. School should not be operated for benefit of any personal use, group or communal purpose.
17. Audit the school by a chartered accountant and submit a copy by the end of June each year to the Deputy Director, BEO.
18. Government Notification (Kannada Language Policy-2016) According to the language policy, the school shall comply with the language policy.
19. Teachers and School Council should follow rules according to R.T.E. Policy, Karnataka Education Act and rules.
20. To comply with the rules and direction of the Government and Department of the School Governing Council.
21. By the end of March each year, SATS has to be mandatorily update school information.
22. If the above conditions are found violated, school accreditation will be cancelled in accordance with the provisions of the RTE Act 2009 and the Karnataka Education Act 1983.
