



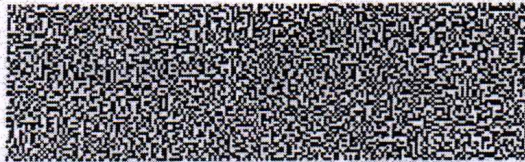

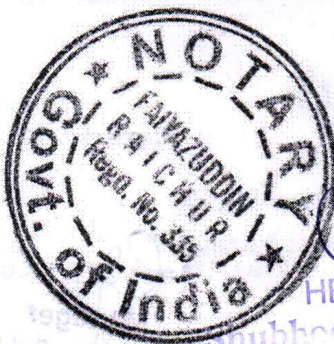

That the Principal and correspondent/manager of the school have individually gone through the provisions contained in the CBSE affiliation & examination bye-laws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination Byelaws, directions issued from time to time and the law of the land.

15. That the school will follow the all rules and regulations which are instructed by the government like RTA, NCPCT, NDMA, NBC (National building code),POCSO, etc.,




